Presentation: Glens Falls Hospital Center for Children and Family	J. Hill, Shared Program Director & T. Ruggiero, Program Coordinator started us off by stating they are fully staffed and have the Open Access Grant starting in January. There are currently 50 people on the waiting list with about a 6 week average wait time before getting services with the youngest being 4 years old (currently 13 waiting). They are running several supplementary groups which are open to youth on the waiting list. This is in an effect to provide some supports until they can get an appointment. It is anticipated that these groups will remain open to the public and referrals for the groups for people not involved in services elsewhere go through Tia; otherwise they need prior Insurance Approval. Health Homes Implementation update	L. Wright stated things continue to move forward with the transformation of services. Waiver will begin transitioning to health home services in January 2019 with all youth transferred by March 31, 2019. She included in our packets the Health Home Serving Children Eligibility, Appropriateness, Enrollment Prioritization and Health Home Six Core Services. Also included, from the Central Field Office is the outline of Children's System Transformation Readiness Guide. SPOA is looking to standardize their application and have it rolled out by January 2019 with DOH approval. J. Robertson added that best practice would be to submit paper referrals to Health Home to avoid glitches in MAP & communications. M. Waskiewicz informed us that Children & Family Treatment Support	N/A

Health Homes Implementation update continued	Services, formally SPA (State Planned Amendment), is based on medical necessity, level of care and global caps for finances. They estimate around 300 youth will be enrolled in these services and they are prepared for launch in January. The Three Services that are going to be provided are Community Psychosocial Rehabilitation (CPR), similar to skill building and social development with a daily maximum of 2 hours, Community Psychiatric Treatments and Supports (CPTS), similar to IH or Crisis Avoidance and Management Training focused on interventions face to face by a licensed or unlicensed practitioner, and Other Licensed Practitioners (OLP), kids without Health Home or Case Managers, providing short term counseling, stabilization, evaluation and referral to wrap around services. They do not have to be enrolled with a Health Home to get Services. The referral process is similar to the Adult process and availability for services is key. Further updates to come in January.	
NYS Systems of Care	L. Wright stated there was a NYS Systems of Care Summit Meeting in September. This is to tie in the theory of change and transition of services through OMH, with the Juvenile Justice system, transitional age into adults, special needs, high fidelity waiver services, and trying to keep kids home with their family and wrap around the support services. The plan for gaps and resources are not final and a technical assistance request is due Oct 19 th . Framework & Education TA request forms, short videos, FAQ sheets and posters are being looked at. We will attach a goals sheet outlining strengths, challenges, opportunities, threats, strategies and revised strategies & priority. M. Simas stated the CASSP principals are very important and the need for more people to get together to spread the information is very important.	N/A
