**NY Connects** is a statewide, locally based point of entry system providing one stop access to free, objective, comprehensive information and assistance on long term care.

A long term care council (LTCC) must exist in each county to conduct long term care system planning and development to ensure achievement of the goals and objectives of the NY Connects.

This council must report their activities and recommendations to the lead agency, who is required to report directly to the county chief elected official, legislative board, or their designee.
