Wright stated the Local Services Plan is usually due to NYS on June 1st; however the date has been pushed back to August 1st due to the pandemic. We will incorporate needs related to COVID-19 impacts, initiatives identified through the law enforcement reform efforts, etc.</p> <p>C. Wright discussed the Law Enforcement Addiction and Mental Health Referral System (LEAMHRS). This will allow officers to make an online referral for same day/next day outreach and engagement efforts. Officer Norton is the new Community Liaison Officer for Glens Falls Police Department. R. York and C. Wright have been facilitating introductory meetings with community provider agencies.
